

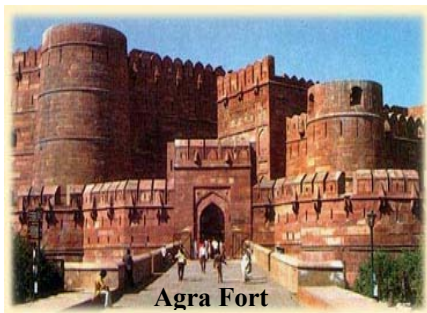

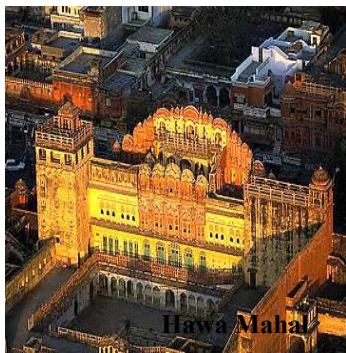

ITINERARY:

Day 01: Arrive New Delhi

Upon your arrival in New Delhi, we would transfer you from the Airport to the Hotel for check-in. Overnight stay at Hotel. [No Meals]

Day 02: New Delhi - Jaipur

After breakfast, drive to Jaipur. Arrive & check into Hotel. Lunch at hotel. After lunch, proceed to market area & indulge in leisure activities like shopping. Dinner & overnight stay at Hotel. [B, L, D]

Day 03: Jaipur

Breakfast at Hotel. Later we would take you out for an excursion to Amer Fort. Lunch at city restaurant. After lunch continue with city tour including City Palace, Hawa Mahal & Royal Observatory. Evening free for independent activities like shopping. Dinner & overnight stay at Hotel. [B,L, D]

Day 04: Jaipur - Fatehpur Sikri - Agra

After breakfast, drive from Jaipur to Agra en-route visiting Fatehpur Sikri. Lunch at Bharatpur hotel. After lunch continue drive to Agra. Arrive & check into Hotel. Dinner & overnight stay at Hotel. [B, L, D]

Day 05: Agra

Breakfast at Hotel. After breakfast, proceed for city tour of Taj Mahal & Agra Fort. Lunch at hotel. After lunch, free time at leisure to indulge in shopping etc. Dinner & overnight stay at Hotel. [B, L, D]

Day 06: Agra - New Delhi [by surface]

Breakfast at Hotel. After breakfast, depart for New Delhi. Arrive & proceed for lunch at city restaurant. After lunch, we would take you out for a combined city tour of New Delhi visiting Qutub Minar, drive past India Gate, Parliament House, Presidents' residence & other government buildings. Day 07: New Delhi - Manila

Breakfast at Hotel. After breakfast, in time transfer to International Airport to board flight back home OR onward destination. [B only].
